WEEKLY PROGRESS UPDATE FOR JANUARY 11 - JANUARY 15, 1999

EPA REGION I ADMINISTRATIVE ORDER SDWA I-97-1019 MASSACHUSETTS MILITARY RESERVATION TRAINING RANGE AND IMPACT AREA

The following summary of progress is for the period from January 11 - 15, 1999.

1. SUMMARY OF ACTIONS TAKEN

Additional drilling crews and equipment were mobilized to the site. Drilling progress as of January 15 is summarized in Table 1. Groundwater profile samples were collected and are summarized in Table 2. Resampling of Phase I wells was initiated. Wells that were resampled are summarized in Table 2. The results of data received is summarized in Table 3. UXO clearance at Demo Area 1 for the proposed soil borings was completed but soil sampling has not started due to standing water at many of the sampling locations. UXO clearance continued in the Impact Area for the drilling pads and access roads for the Phase II (a) wells. A 4.2" mortar HE with fuze was found while clearing the drilling pad for well MW-37. A round of water table measurements was collected in the vicinity of Demo Area 1 on January 12; results are summarized in Figure 1.

4. SCHEDULED ACTIONS

Scheduled actions for the week of January 18 are as follows. Drilling will be initiated at MW-35, which is a Demo-1 response well down-gradient of MW-34. Drilling will be continued at the other wells described above. After wells MW-47, MW-52, and MW-53 are completed, drilling will be initiated on MW-50, MW-51, and MW-54. UXO clearance will continue for the drilling pads and access roads for the Phase II (a) wells.
